### Privacy policy according to EU GDPR

#### Please note:

- \*Proof must be submitted to the association immediately and thereafter no later than December 15th of each year
- The age reached on July 30th of a year is used as the basis for classification in the respective contribution type
- Sustaining members as passive members cannot book the indoor tennis center at a discount
- If a member plays with a guest, the guest as a matter of principle **must always book** the court. Guests must register in our court booking system via [www.tcaurachtal.de](http://www.tcaurachtal.de) before the first game. This allows both outdoor and indoor courts to be booked. For outdoor courts: Guests pay 10 € per hour and the fee will be debited automatically. A maximum of five guest hours are possible once. Outdoor court fees paid in the year of joining will be credited.
